# ABOUT THE RIVER DISTRICT

The River District is a private, nonprofit business association charged with managing and promoting programs to strengthen the economic and cultural well-being of the area.


The 830-acre Property and Business Improvement District (PBID) was established in 1999 by a broad-based coalition of public and private property owners. Managed by The River District, the PBID is a special benefit assessment that supports enhanced services.

The PBID was approved for a ten-year term in 2024. The 2025-2034 Management District Plan outlines three categories of services to be provided by the PBID: safety & maintenance; planning, advocacy & communication; and administration & reserve. The services and programs provided by the PBID are above and beyond those provided by the City and County of Sacramento.

**Location:** Approximately 830 acres bounded roughly by the American River to the north; Sacramento River to the west; Union Pacific rail berm and C/D streets to the south; and 27th Street to the east.

Activities: Safety & Maintenance provides daily private security patrol, weekday trash abatement and on-call graffiti removal, regular liaison with the Sacramento Police Department, and occasional weed abatement. Planning, Advocacy & Communications activities facilitate a strong and organized voice to represent and convey a positive image of the assessed parcels. This program will advocate to advance the design and implementation of new roadway, transit, utility, and streetscape projects and advocate for open space, amenities, and other projects which specially benefit assessed parcels. The activities will aid in the attraction and retention of businesses, jobs, and employees.

Administration of District programs and activities is provided by The River District professional staff and Board of Directors.







Our Vision: A vibrant, mixed-use urban community with an eclectic mix of residential and commercial land uses topped off with riverfront views and a variety of parks, plazas and open space.

# EXECUTIVE DIRECTOR'S MESSAGE

The River District celebrated its recent renewal for another ten years, and all the progress that has been made in the past year, at our third annual State of the River District on April 15, 2025. We were thrilled that Blue Diamond Growers hosted the event in their historic headquarters right here in the District, utilizing the porte-cochère, lobby, and employee theatre. The event featured a moderated panel that included Sacramento Mayor Kevin McCarty, Councilmember Phil Pluckebaum, and County Supervisor Phil Serna. The panel was moderated by Michelle Bandur, a reporter with KCRA News which is now a member of the River District after our expansion which went into effect at the beginning of this year (as part of our renewal).

Later in April, we participated in Celebrate Trails Day with our Trails in Bloom event. Celebrate Trails Day is an annual spring celebration of America's trails, started by Rails to Trails Conservancy in 2013. Trails in Bloom was one of over 275 events across the county aimed at recognizing the importance of exercise, as well as the culture and history of our environments. At Trails in Bloom, we cleaned up a stretch of our river parkway at Township 9, hosted three social bike rides and a festival at Hanami Line, in addition to celebrating Earth Day.

In June, we hosted our second quarterly Friends of the River District Block Party, which also featured a pop-up market. This event was hosted at The Hayley, the River District's newest apartment community, at Township 9. Residents participated in games and activities, as well as patronizing local vendors and a fresh produce stand. We look forward to our next Block Party to encourage our neighbors to get to know one another.

Lastly, we were proud to support the Sacramento Tree Foundation's Evening at Hanami Line event. Since its opening, the Hanami Line has reinvigorated the portion of our waterfront on the west end of the River District, bringing a beautiful new forest of cherry blossom trees that already produced some blooms this spring. It will only grow more breathtaking in the future!





#### **Sacramento Air Travel**

Sacramento International Airport set a record in June with nearly 1.3 million passengers, capping 19 months of year-over-year growth. SMF served 13.8 million travelers in fiscal 2025 and is advancing its \$1.4 billion SMForward expansion, adding parking, a rental car center, terminal upgrades, and at least six new gates. To fund the next phase, the airport will issue \$412 million in bonds Aug. 5, with no local tax dollars.

#### State of the River District Focuses on Homelessness

The third annual State of the River District took place April 15, 2025, at Blue Diamond Growers, with a panel moderated by KCRA's Michelle Bandur featuring Mayor Kevin McCarty, Councilmember Phil Pluckebaum, and County Supervisor Phil Serna. Blue Diamond's Alicia Rockwell welcomed guests to the historic facility, and River District Board President Ahmed Hamdy thanked sponsors and emphasized the district's "bold, intentional growth."

Discussion focused heavily on homelessness and its impact on local businesses. McCarty called it the city's "singular focus," citing new tiny home projects, while Pluckebaum stressed public safety and shelter access, and Serna highlighted new safe space communities, with the county currently constructing its fourth project.

The event concluded with River District Executive Director Devin Strecker presenting the inaugural Visionary Award to Board Secretary Greta Lacin for her persistence and contributions to the district.

# **RIVERFRONT & RAILYARDS**

#### **Soccer Stadium Moves Forward Despite Protest**

Despite loss of funding tool, Republic FC's new venue and surrounding development still set to proceed.

Plans to expand a special financing district for the Sacramento Railyards have expected to begin later this year, and been halted after more than half of current residents submitted protest letters, city officials announced Monday. The expansion, approved unanimously by the City Council in June alongside agreements to build Sacramento Republic FC's new 12,000-seat stadium, was meant to help fund infrastructure across the 244-acre site.

The vote to approve the stadium drew a packed house of supporters, who celebrated the long-awaited project that also includes housing, a hospital, a music venue, and retail. While the stadium and existing financing district remain on track, the failed expansion means the city and developers will seek other funding sources — without tapping the General Fund – to cover infrastructure needs.

Work on the Central Shops Plaza is still Republic FC says it remains committed to for a spring 2027 opening.
